AFFIANT, JOHN J. FEYEN, being duly sworn, deposes and says:

THAT he has probable cause to believe that the person known as TANNER FLORES, DOB: 10/31/1997, has committed the following criminal offense(s), namely:

- 1. CRS 18-3-102(1)(a) MURDER IN THE FIRST DEGREE CLASS 1 FEL 1 COUNT(S)
- 2. CRS 18-3-302(1) 2<sup>nd</sup> DEGREE KIDNAPPING CLASS 3 FEL 1 COUNT(S)

THAT the facts establishing probable cause, and grounds for issuance of an arrest warrant, are:

- 1. That the Affiant is of lawful age and is a duly sworn law enforcement officer currently employed as a Lieutenant in the Investigations Division of the Larimer County Sheriff's Office and was so at all times relevant to the facts contained herein. All of the information herein contained was compiled by the Affiant in the course of a criminal investigation, including speaking with fellow law enforcement officers and named citizens. All locations referred to are in the County of Mesa, State of Colorado, unless specifically noted otherwise.
- 2. On Friday, June 10, 2016 at about 0617 hours, MCSO deputies were contacted by Sgt. Bob Heffernan with the Larimer County Sheriff's Office. Sgt. Heffernan advised Deputy Darin Huisjen they were investigating a potential missing person / kidnapping incident and it was believed the suspect and victim were potentially in Mesa County, Colorado.
- 3. Sgt. Heffernan provided your Afflant with the following information regarding the initiation of this incident.
  - That on 09 JUNE 2016, at about 1955 hrs (GMT-6) a call came into Larimer County
    Communications (LCC) from the bank at 1439 hrs (GMT -6) and had not returned as of 1930 hrs (GMT -6). Told LCC that she had found her daughter's car unoccupied at Lon Hagler Reservoir.

    informed LCC that she was with the car at 5001 W CR 16E, Loveland, Larimer County, Colorado.
  - It was learned that the back feemly broken off a relationship that had been ongoing for over a year with TANNER FLORES (DOB: 10/31/1997).
  - According to "upset" over the breakup with ASHLEY. (Description), a friend of TANNER's, TANNER was "upset" over the breakup with ASHLEY. (Description), another friend, stated that TANNER was "really down" over the breakup and did not know why they were no longer together.
  - LCSO Investigator WEBER learned through interviews that TANNER's friends stated that they had never seen TANNER so "depressed" over the breakup.
  - Ryan Adams that his .22 Cal revolver was missing from the locked gun cabinet in the FLORES' home. SHAWN stated the last time he knows this revolver was in the cabinet was this past summer. SHAWN advised Larimer County Sheriff Deputies that TANNER knew where the key was to this cabinet. SHAWN described the gun as a revolver with red cherry wood grips.

- Deputies learned from friends that TANNER's phone number was
- Investigator WEBER received information from regarding an application on her cell phone which showed ASHLEY's recent text messages and phone calls on June 9, 2016. This application showed text messages between 3 and TANNER (970-619-0877) on June 9, 2016 at 1313, 1316, 1323, 1324, and 1326 hours. There was no content associated with these times. In addition, this application showed phone calls between ASHLEY and TANNER at 1334 and 1358 hours.
- TANNER apparently sent a snapchat message to several friends on 8 JUNE 2016 in the late evening that had a message that was suicidal in nature.
- According to families of both
   and TANNER, for them to not be in cell contact either through text message or phone calls was highly unusual and concerning to them.
- Deputies requested emergency ping information from Verizon pertaining to both and TANNER's cell phones, based on exigency information that one or both of them were in danger of serious bodily injury or death.
- Information gained from the emergency request shows that TANNER's and phone were within miles of each other during the time frame of 1601 Hrs (GMT-6) to 1618 Hrs (GMT-6) on 9 JUNE 2016. After that Verizon records shows cell phone as inactive. TANNER's cell phone continues to register with towers until 1700 Hrs (GMT-6) when it then goes inactive. A phone status of inactive according to Verizon could be due to several different scenarios to include a powered off phone.
- 4. Sgt. Heffernan advised Deputy Huisjen that the informed them Tanner Flores was possibly headed to his grandfather's residence at 64006 Hwy 330, Collbran, Mesa County, Colorado.
- 5. The suspect's family advised Sgt. Heffernan the family spoke with a neighbor of the deceased grandfather's property identified as a supplied to the family that Tanner Flores' truck was in fact parked in the driveway.
- 6. Your Affiant learned from Mesa County Investigator DANNY NORRIS original affidavit the following information:
  - That Deputy Heisjen spoke by phone with (DOB), who lives in the residence to the east of the address. While he was on the phone with she advised Deputy Huisjen she could see a male who she thought to be Tanner Flores outside of the house near the white truck parked in the driveway. The told Deputy Huisjen she saw that the male had opened all the doors to the truck, and pulled out what looked to be a bundled up blanket from the back seat of the truck and set it on the ground. The said she was not totally sure, but she thought she could see an arm sticking out of the bundle.

- Deputy Huisjen remained on the phone with the who continually monitored the residence. Law enforcement first arrived and observed the residence from a distance since about 0846 hours.
- MCSO SWAT responded to the scene and established a perimeter and observed the male's
  actions. The male was observed near the truck and the residence but no female was observed
  with him. At one point the male was observed throwing something in the field north of the
  residence that the deputies believed was a rag with potential blood on it. The male was also
  observed with something black in his hand.
- The residence was reported to be unoccupied as Tanner's grandfather was deceased. The
  residence was reportedly cleaned out and locked.
- SWAT deputies contacted Tanner Flores and placed him in custody at about 1032 hours.
- SWAT deputies observed a deceased body in the back of the Dodge Truck (CO Plate 121XGQ).
   Plateau Valley Paramedic Brad Siler spoke by phone with St. Mary's ER Doctor Brent Fowler who pronounced the victim deceased at about 1102 hours.
- 7. Your Affiant had the opportunity to observe Investigator NORRIS' interview of Tanner Flores. During the interview Tanner admits to:
  - Shooting in the head twice because he is angry with her.
  - The shooting took place near Carter Lake in unincorporated Larimer County Colorado.
  - Carrying body into the residence in Collbran and cleans her up before returning her to the truck,
  - Throwing bloody cloth away on the property and a bloody rug away in a silo.
- 8. That your AFFIANT believes the aforementioned facts to be true from reports and records, and/or from personal conversations with citizen informants or fellow officers and/or from personal observations and knowledge.
